**No stand may be vacated in whole or in part before the end of the exhibition. In the event of non-compliance, the deposit of 200 euros will be forfeited.**

### 3. Stands

The stands are delivered ready for occupancy by the organiser. The partition walls are approx. 2.25 m high and may be nailed up. Use sturdy stand shelves and **not shelves that rest on angle brackets** that have to be screwed to the partition walls. Metal brackets for gun racks or hanging racks etc. can be hung and screwed over the top edge of the walls. All nails and screws must be removed at the end of the event. The stands are closed off at the front by an approx. 20 cm wide top panel that ends at the top edge of the frame. This may be nailed.

### 4. Exemption licence

Every supplier of weapons requiring a licence, unlicensed weapons and cutting and thrusting weapons must submit an application for a special permit in good time before the start of the trade fair (see attached application). Firearms subject to authorisation may be offered.

### 5. Compliance with §86a StGB

The exhibitor undertakes to strictly comply with Section 86a of the German Criminal Code (StGB) in the version dated May 31, 1978, according to which, among other things, the display, exchange, and trade of items bearing the symbols of former National Socialist organizations or which are visibly marked with such symbols is prohibited. The stricter provisions of the Weapons and War Weapons Control Act must be strictly observed. The trade in counterfeits or reproductions is prohibited. The exhibitor also undertakes to strictly comply with §40 WaffG (Weapons Act). Translated with DeepL.com (free version).

In the event of violations of the provisions of §86a StGB and the provisions of the Weapons and War Weapons Control Act, the exhibition management has the right to close and dismantle the exhibitor's stand immediately. Any claims for damages are excluded.
